## **Agreement for Utility Payment**

This Agreement for Utility Payment ("Agreement") is made and entered into between Village of South Roxana ("Village") and you, the undersigned individual ("Customer"), collectively referred to as "Parties."

WHEREAS, the Customer is currently behind on their water bill with the Village, and

WHEREAS, the Village is willing to provide an opportunity for the Customer to settle their outstanding balance in a manageable manner, while ensuring future payments are made promptly.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

Outstanding Balance: The Customer acknowledges that they owe an outstanding balance to the Village for unpaid water bills (the "Delinquent Account").

Payment of Current Bill: The Customer agrees to pay the current water bill in full, without any delay or default. The amount due for the current bill **shall be paid by the 15th of each month**.

Monthly Additional Payment: In addition to the payment of the current bill, the Customer agrees to pay an extra amount each month towards the Delinquent Account. This additional payment shall be made along with the regular monthly water bill payment.

Duration of Additional Payments: The Customer shall continue to make the additional monthly payment until the full amount owed on the Delinquent Account is paid in full.

Late Payments: In the event that the Customer fails to make the additional monthly payment by the due date, they shall be considered in default of this Agreement. The Village reserves the right to take appropriate action, which may include but is not limited to, disconnection of water services, additional penalties, or legal recourse.

No Waiver: The failure of the Village to enforce any provision of this Agreement shall not be considered a waiver of that provision or any other provision contained herein.

Entire Agreement: This Agreement constitutes the entire understanding between the Parties concerning the subject matter hereof and supersedes all prior discussions, negotiations, and agreements, whether oral or written.

Amendment: This Agreement may only be amended in writing, signed by both Parties.

Governing Law and Jurisdiction: This Agreement shall be governed by and construed in accordance with the laws of Illinois. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts in Madison County, IL.
